City Manager Weekly Report February 23, 2024

Park Zone Speed Enforcement Update

Our staff has overcame significant obstacles this week in efforts to finalize installation and activation of the Speed Enforcement Cameras in the Redondo Park Zone. The City received our much-anticipated approval from the Administrative Office of the Courts for our penalty schedule and infraction notices. As I have stated before, the City will be the first in the state to install Park Zone Speed Enforcement Cameras that were only recently authorized by state law. Because of this, there was no playbook for us to follow, and our staff has had to navigate through a variety of issues, both foreseen and unforeseen. Power installation has been completed at both sites (Redondo Beach Dr. and Redondo Way S.), and now the final item we are waiting on is for our vendor to finalize the backend software required to run this program. The projected date for this completion is March 31, which would enable us to begin the 30-day warning period shortly thereafter.

Former Masonic Home Demolition

The Public Comment Period on the Draft Environmental Impact Statement for the Zenith Properties Demolition Application at the former Masonic Home/Landmark on the Sound remains open until March 8th. You can access the Draft EIS and provide your input by visiting the City of Des Moines project webpage here. The City has received many questions and comments from the public related to the City Council's role in this process. The decision for the pending demolition application is not a City Council decision. Not only does the Council not have a role in the decision making process, they have been advised both by the City Attorney and the City's insurance provider not to comment on the application as it could be viewed as an attempt to improperly influence the decision making process. State law and the City's Municipal Code govern the environmental process that is currently underway and designate the City's SEPA official as the decision-maker (<a href="https://pmmc.ndm.nih.gov/pm
