Recreation Opportunities

On February 17th, the City will be hosting a Youth Racket Sports Clinic. Kids age 7-12 are eligible to sign up to learn and/or sharpen their skills in tennis and pickle ball (the official State Sport of Washington) on indoor courts at the Field House. Murder Suspect Convicted

After a meticulous investigation and a thorough trial process, justice has been served in the case of the tragic murder of 31-year-old Andrew Carter. On October 28, 2018, Des Moines police officers responded to a 911 call reporting a shooting at the Redondo Square parking lot. Despite immediate life-saving efforts by officers and South King Fire and Rescue, the victim succumbed to his injuries at the scene. In collaboration with public assistance and video surveillance evidence, Des Moines Police detectives identified a suspect and apprehended him a few days later. Senior Detectives Mike Thomas and Fred Gendreau conducted a thorough interrogation of the suspect and ultimately obtained a confession. The case proceeded to a jury trial in January 2024, where the tireless efforts of Detectives Thomas, Gendreau, Emly, and West, alongside the initial responders, Records and Evidence staff, and the King County Prosecutors Office, culminated in a conviction on all charges.
