PROPOSAL	The property owner, Zenith Properties L.L.C. (Zenith) has applied for a demolition permit to remove all structures of the former Masonic Home/Landmark on the Sound. The City of Des Moines SEPA Official has determined this proposal is likely to have a significant adverse impact on the environment, and accordingly, an Environmental Impact Statement (EIS) is required under Revised Code of Washington (RCW) 43.21C.030(2)(c). The City will act as lead agency for this EIS.  The Draft EIS stage is the second stage in the EIS process and includes a public comment period. The EIS will analyze the particular environmental concerns that were identified during the scoping stage. The City is notifying the public of the Draft EIS availability and the opportunity to comment on its analysis.
